This timely session about advocacy will include a case study on the passage of an Illinois law allowing dentists to administer the flu vaccine. Illinois is the only state in which dentists, with certified training, can legally administer the vaccine to the adult population. The presentation will review the process, from formulating the initial concept to delivering proposed legislation to a legislative body. It will also explore strategies for countering resistance, such as opposition from a state medical society.

## **Technology and Advancements: Silver Diamine Fluoride for Arresting Dental Caries**

Milona Van Kanegan, DDS, MS, MPH, Chief, Division of Oral Health Promotion, Illinois Department of Public Health

Silver Diamine Fluoride (SDF) is an interim caries arresting liquid medicament clinically applied to control and prevent the further progression of active dental caries and reduce dentin hypersensitivity. This treatment allows oral health care professionals to arrest dental caries with a noninvasive, painless, and quick method across the age spectrum. SDF treatment is highly effective in arresting dental caries, and the American Academy of Pediatric Dentistry recommends that treated areas be actively monitored with a follow-up evaluation plan. Many groups can benefit from this intervention, including the very young, individuals with disabilities or special health care needs, the elderly, and others with inconsistent access to dental treatment services.

- Understand the mechanism of action of Silver Diamine Fluoride (SDF).
- Identify appropriate cases for treatment with SDF.
- Review clinical protocols for this treatment.
- Learn how to develop a follow-up plan.
- Understand considerations for formulating policy for regulating of SDF.
